In terms of Section 33 of the Rights of Persons with Disabilities Act, 2016, sanction is hereby accorded to the constitution of Expert Committee comprising the following:

01.	Administrative Secretary, Finance Department	Chairman
02.	Administrative Secretary, Social Welfare Department	Member
03.	Administrative Secretary, General Administration Department	Convenor
04.	Two employees with benchmark disabilities to be nominated by GAD	Member
05.	One member from NGO dealing with persons with disabilities to be nominated by the Social Welfare Department	Member (Technical Experts)

The Terms of Reference of the committee shall be as;

- i. To identify posts in the establishments which can be held by respective category of persons with benchmark disabilities in respect of the vacancies reserved for the disabled by the Government.
- ii. To consider the list of the posts (Gazetted and Non Gazetted) identified for persons with disabilities in various departments vide Government Order No. 147-SW of 2014 dated 17.06.2014 for adoption/ modification.
- iii. To undertake periodic review of the identified posts at an interval not exceeding 03 years.


