Consequent upon the winding up of Jammu and Kashmir Backward Classes Commission vide Government Order No. 119-JK(SWD) of 2020 dated 29.05.2020, and constitution of the Jammu and Kashmir Socially and Educationally Backward Classes Commission vide Government Order No. 2230-JK(LD) of 2020 dated 19.03.2020, the assets and liabilities/ Staff of the erstwhile Jammu and Kashmir State Backward Classes Commission is, hereby, ordered as under:

  - (iv) All records pertaining to the erstwhile Jammu and Kashmir Backward Classes Commission shall be transferred to the Jammu and Kashmir Socially and Educationally Backward Classes Commission.
