## Terms & reference:

The sub-committee for short listing the candidates shall thoroughly scrutinize the applications along with the documents received and prepare a score card on a scale of 100 points, out of which 30 points shall be reserved for the interview by the Selection Committee and score against 70 points shall be awarded by the sub-committee as per following parameters/criteria.

## A. Academic merit:

- a. Graduation Degree with one of the subject in the fields prescribed in section 17(2) of the Act: 50 points.
- b. Additional 05 points to be awarded for post graduation in the relevant field.

## B. Experience:

a. For the experience of 10 years in the relevant field: 10 points to be awarded and 01 point each for additional 02 years of experience subject to maximum of 05 points.

b. For purpose of experience, the certificate issued by the competent authority of the concerned Government/Statutory body/Autonomous body shall only be considered.

In case of any doubt, the decision of the Administrative Secretary, Social Welfare Department shall be final and binding.
