- That the appointee(s) shall furnish an undertaking in the enclosed format that no ii. criminal records and also not facing any criminal proceeding in any Court of Law.



- iii. The salary of the appointee(s) shall not be drawn and disbursed to them unless satisfactory report in respect of qualification/other certificates are received from the concerned authority.
