Whereas, a complaint regarding illegal engagements of Anganwadi Helpers/ Anganwadi Workers in ICDS Project Iddgah and ICDS Project Zaldagar and others was received in the Office of Directorate General, Women and Child Development;

Whereas, among others Mrs. Samina Ali, I/c CDPO was found involved in illegal appointments made in ICDS Project under her charge;

Whereas, Mission Director, ICDS (now Poshan) was appointed as Inquiry Officer who submitted her report which was examined in this department and vide Govt. Order No.70-JK(SWD) of 2022 dated 30.03.2022, it was ordered that:-

- 1. Mission Director (ICDS), J&K shall re-insate Ms. Samina Ali in her substantive capacity and she shall not be given the charge of any project as she has failed to perform her duties as warranted under Law.
- 2. Mission Director (ICDS), J&K shall recover honorarium paid in favour of illegally appointed/elevated AWWs/AWHs from the salary of the Ms. Samina Ali, the then I/C CDPO, ICDS Project Eid Gah and Zaldagar.

Whereas, the Mission Director, Mission Poshan re-instated the official in her substantive capacity as Supervisor and intimated that an amount of Rs. 1,86,252/- has been recovered from Ms. Samina Ali, Supervisor (now retired) and also intimated that the illegal engagement of AWWs /AWHs who have already been disengaged and are not performing duties;

Whereas, Samina Ali, submitted representation before the Mission Director, Mission Poshan for treating the period of suspension as on duty as she attended the

Office of Directorate General, Women and Child Development during the period of her suspension from 05.10.2020 to 29.04.2022 and the Mission Director sought

Whereas, the matter has been examined and it has been found that fact remains that the said official has not be exonerated upon inquiry thought she has been re-

Now, therefore, the suspension period of Ms. Samina Ali, Supervisor (now retired) from 05.10.2020 to 29.04.2022 is treated as leave whatever kind due to her.
