Sanction is hereby accorded to the advance drawl of **Rs.292.66 lakh** (Rupees Two Crores, Ninety Two lakh and Sixty-Six Thousand) only in favour of Accounts Officer, Mission Directorate ICDS for further placement of the amount at the disposal of Gram Panchayats through their Bank accounts for procurement of Supplementary Nutrition items for Anganwadi Centres during 2020-21 for the month of May & June under " Supplementary Nutrition Programme (SNP).

The sanction is subject to the following conditions:

1. The funds are utilized for the activities as per originally approved components and according to norms and guidelines prescribed by Government of India/State Government from time to time.
2. Mission Director, ICDS shall vouchsafe the proper utilization of funds and shall be responsible for submission of the Red account of the amount to Accountant General office in time bound manner under intimation to this department.
3. The funds are utilized strictly for the purpose these are released without creating any liability for future;
4. No diversion of funds is allowed without prior approval of the Competent Authority;
5. That there is no overlapping in funding under the scheme from any other scheme of the State/central Government or any of its organisation/institutions;
6. The utilization certificate for these funds is furnished to the Social Welfare Department duly countersigned by the State Mission Director ICDS immediately after incurring the expenditure.
7. The expenditure is incurred after observing all the codal formalities required under rules/regulations.
8. The physical targets commensurating with the release of funds are achieved in full .
9. The Physical/ Financial Progress Report under the Scheme on monthly basis is to be submitted to the Administrative Department by or before 10th of each month, henceforth.
