 - iii. To Supervise & Monitor the Procurement, expenditure, quality control, hygiene & other related issues;
 - iv. To Resolve the other issues of ICDS sector which are referred to the committee.
 - v. The District Monitoring Committee shall take due cognizance of recommendations of Block Development Council for overall improvement of the procurement policy.


