Subject: Creation of the separate Directorate of Women & Child Development and Delegation of Powers to Director General, Women and Child Development.

In continuation to Government Order No. 146-SW of 2019 dated 13-06-2019, Sanction is hereby accorded to the Delegation of following Powers to Director General, Women & Child Development, J&K with immediate effect:-

- I. Mission Director, ICDS (who shall continue to function as Project Director POSHAN Abhiyaan), and Mission Director, ICPS, shall report to Director General, Women & Child Development.
- II. All the plans of ICDS and ICPS shall be duly vetted by the Director General, Women & Child Development and submitted to Administrative Department.
- III. He/She shall receive, evaluate & review the MPRs, QPRs & APRs from the MD, ICDS and MD, ICPS.
- IV. He/She shall submit annual report of Women & Child Development to the Administrative Department
- V. He/She shall evolve plans, policies, strategies, mobilizing resources, bringing convergence of common programmes, monitoring of laws, schemes and programmes relating to women and children.
- VI. Transfers and posting of staff working in ICDS / ICPS shall be approved by the Director General. However, the proposal of pre-mature transfers and postings of Gazetted Staff shall be recommended to the Administrative Department.
- VII. He/She shall be the Chairman of state level purchasing committees and MD, ICDS and MD, ICPS shall be co-chairperson of these committees.
- VIII. He/She shall recommend the budget estimates Plan and Non-plan to the Administrative Department in respect of both Directorates.
- IX. He/she shall be competent to sanction 75% of GPF advance to all the employees subordinate to him/her.
- X. He/she shall be the authority for recommending proposals for sanctioning of new Anganwadi centers in Jammu & Kashmir.


