Subject: Revision / updation of the list of identified posts for persons with Disabilities.

Government Order No:- 95 JK(SWD) of 2022

D a t e d:- 20 -05-2022

Whereas, Social Welfare Department vide Government Order No. 59 –JK (SWD) of 2021 dated 15/04/2021 notified the list of identified posts (gazetted/non-gazetted) suitable for persons with benchmark disabilities in respect of various departments under Rights of Persons with Disabilities Act, 2016 in Annexure-A to said Government Order.

Whereas, in Annexure-“A” to the aforesaid Government Order the following posts shown in respect of Rural Development Department have been mentioned:

Designation of the Post	Physical Requirement	Categories of disabled suitable for jobs
1. Gram Sevika	Sitting, Standing, Reading and writing	One leg, one arm, low vision
2. Village Level Workers	Sitting, Standing, Walking, Seeing, Reading and writing	One leg, one arm, hearing impairment, low vision
3. Multipurpose Workers	Sitting, Standing, Walking, Seeing, Reading and writing	One leg, one arm, hearing impairment, low vision

Whereas, the Department of Rural Development in the file bearing computer no. 49700 has referred the matter to this Department stating that all these aforesaid posts viz. Village Level Worker, Multipurpose Worker and Gram Sevika stand re-designated/merged as Panchayat Secretary vide Govt. Order No.59-RD&PR of 2021 Dated 02/03/2021 which was issued on the basis of the concurrence of the Finance Department and the decision of Administrative Council conveyed by the GAD;

Whereas, the Department of Rural Development has requested the Social Welfare Department to modify the said Annexure-A to G.O. No.59-JK (SWD) of 2021 dated 15/04/2021 to the extent of including the posts of Panchayat Secretaries instead of Village Level Worker/Multi Purpose Worker/Gram Sevika in the said Annexure-A;

Whereas, the matter has been examined in the Department and it is accordingly decided to modify the Annexure-A to the G.O No.59-JK (SWD) of 2021 dated 15/04/2021 so that the horizontal reservation to the persons with bench mark disabilities could be provided in Rural Development Department in terms of Right of Persons with Disabilities Act, 2016;

Now therefore, the entries at Serial no. 1, 2 & 3 under the heading Rural Development Department in the Table shown in Annexure-A to the G.O No.59-JK (SWD) of 2021 dated 15/04/2021 shall stand substituted by the following entry:

Designation of the Post	Physical Requirement	Categories of disabled suitable for jobs
I.Panchayat Secretary	Sitting, Standing, Walking, Seeing, Reading and writing	One leg, one arm, hearing impairment, low vision

This order is issued in pursuance to Section 34 of the Rights of Persons with Disabilities Act, 2016.


